VPO BESPOKE PACKAGE

Our costs for the BVPO package will be based on requirements. Cost and time estimates will be provided.

VPO LIGHT PACKAGE

We understand that some of our clients have an inherently lower risk and therefore may wish to have a reduced VPO service.

For the VPO light package our costs are from £950 (plus VAT) per month capped at a maximum of 4 hours work per month.

Tasks	What is included?
Data breach support	Direct support that will assist in decision making and actionable tasks.
Data subject access requests (DSAR's)	Direct support that will guide you through the DSARs process, and provide access to templates. <i>NB: some DSARs are very time consuming and complex, so because of this we are unable to provide full DSAR support within this package. We are able to provide full DSAR support as and when needed which would be costed separately.</i>
Privacy impact assessments (PIA's) and legitimate interest assessments (LIA's)	PIAs and LIAs are regularly needed in most businesses when undertaking a new project or implementing new technologies that affect the processing of personal data. Templates and reviews of completed PIAs or LIAs form part of this support package.
Website review	We will conduct a desktop review of your website and ensure it is compliant with data protection and privacy requirements. We can provide you with advice and recommendations following this review.
Policies and procedures	Advising on the policies and procedures you need to ensure you are compliant. Each policy and procedure will be quoted for separately.
Ad-hoc privacy questions or concerns	Direct support within working hours up to an hour a month.

VPO FULL PACKAGE

The full VPO package will allow you to have a complete virtual privacy officer service with expert advice.

For the VPO full package our costs are from £1,750 (plus VAT) per month, capped at a maximum of 8 hours work per month.

Tasks	What is included?
Data breach support	Direct telephone support that will assist in decision making and actionable tasks. Some administration support, including helping with data subject communications where needed.
Data subject access requests (DSAR's)	Direct telephone support that will guide you through the DSARs process, and provide access to templates. <i>NB: some DSARs are very time consuming and complex, so because of this we are unable to provide full DSAR support within this package. We are able to provide full DSAR support as and when needed which would be costed separately.</i>
Privacy impact assessments (PIA's)	PIAs are regularly needed in most businesses when undertaking a new project or implementing new technologies that affect the processing of personal data. Templates and reviews of completed PIAs form part of this support package.
Identifying lawful basis	We can assess and define the correct lawful basis for each processing activity (via PIA's, as above). This will include conducting legitimate interest assessments (LIA's), which is a balancing test of your legitimate interest to process personal data and the rights and freedoms of any data subjects.
Website review	We will conduct a desktop review of your website and ensure it is compliant with data protection and privacy requirements. We can provide you with advice and recommendations following this review. We also be able to provide you with the required website policies as listed below.
Policies and procedures	Drafting bespoke policies and procedures for both internal and external use to ensure your compliance (depending on your business needs). The types of policies and procedures may include: privacy policy; internal privacy standard; internal data protection policy; email use policy; working from home policy; cookie policy; records retention policy; bring your own device (BYOD) policy; CCTV policy; data breach procedure; data subject access request procedure etc.
Physical PEN tests	Conducting physical 'PEN tests' to ensure the physical security of your building.
Acting as a contact for the ICO – registration, breaches, enquiries, complaints etc...	Acting as a point of contact between yourself and the Information Commissioner's Office on matters such as registration, data breaches, general enquiries, complaints etc.
Ad-hoc privacy questions or concerns	Direct support within working hours.

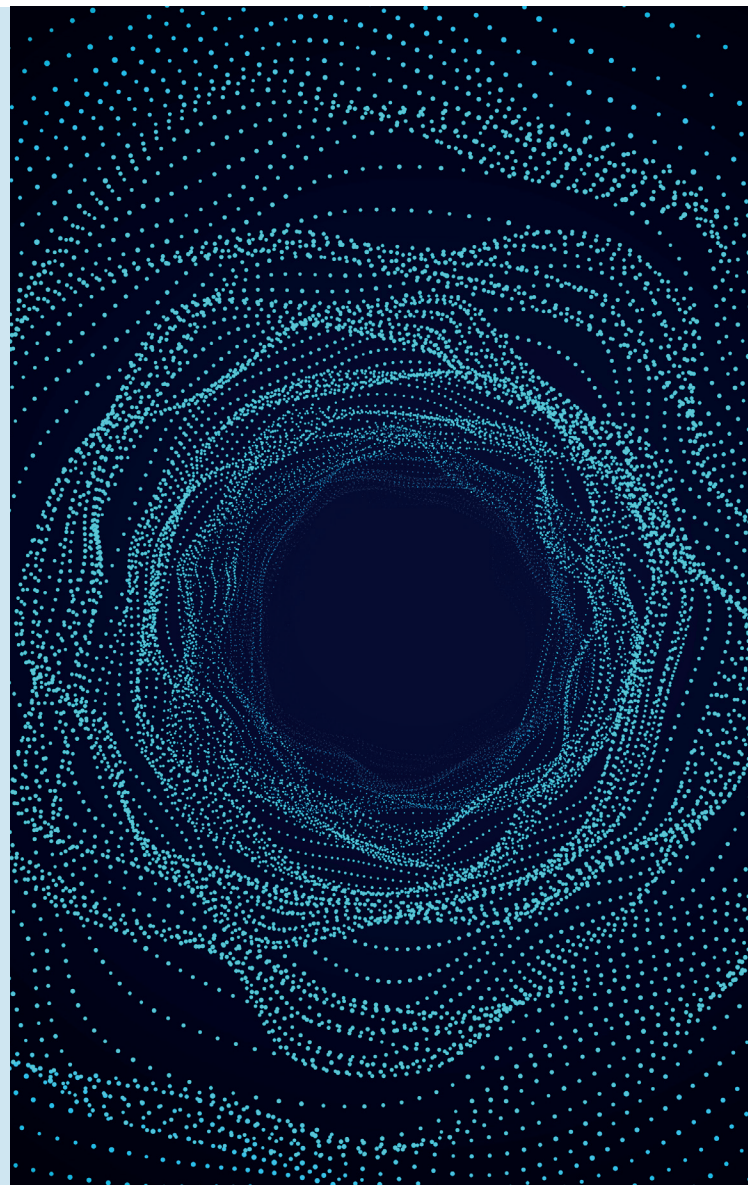
