Legal aid is no longer available for the vast majority of UK immigration applications. In any event, we do not offer legal aid assistance in immigration matters. That said, our specialist team of Immigration Lawyers offer competitive fixed fees in immigration matters. We use the most appropriate person for the work required and our average hourly rate is £220.

The exact legal fees payable depend on the circumstances in your case. If you can provide sufficient evidence and information at our initial meeting and clearly meet the applicable Immigration Rules, the cost is likely to be at the lower end of the fee range. If any of the following apply our legal fees are likely to be towards the higher end of the fee estimate:

- you have had previous immigration issues
- you are applying with dependants
- you do not meet the eligibility criteria for the visa and/or your circumstances change during the application process
- you have a criminal record

WHAT WORK IS INVOLVED IN THE PROCESS?

- discussing your circumstances in detail and confirming what is the most appropriate application for you to make and what other options may be available to you;
- giving you verbal and written advice about the requirements of the Immigration Rules that you are intending to apply under and whether you meet the criteria
- if you do not fulfil certain criteria, whether this can be overcome and if so, providing you with proactive advice on how this can be done;
- reviewing/advising you on the supporting evidence you have provided* and where necessary, assisting you with obtaining further evidence (such as medical records, reports and witness statements);
- advising you on the timelines and likely outcome of your application
- preparing your application and submitting it to the Home Office on your behalf;
- being named as your legal representative on the application and liaising with the Home Office (where required) during the application process
- supporting your application with a letter of representation setting out how you meet the requirements for the route under which you are applying
- booking your biometric appointment and uploading your supporting documents to the Home Office systems in advance of your appointment
- if the Home Office ask you to attend an interview, we will give you clear advice at the appropriate time
- following the decision, we will provide you with written advice about the outcome of your application and any further steps you need to take

**The number of hours required depends on how many documents you have provided, whether they need to be translated, whether anything is missing and how long it will take to obtain the missing documents*

EXPENSES (NOT INCLUDED IN COSTS SET OUT ABOVE)

In addition to our fees, there may be additional expenses applicable to your application, such as Home Office application fees. These expenses are referred to as disbursements. We may handle the payment of the disbursements on your behalf to ensure a smoother process. All disbursements are not included in the fees set out above, but may include:

- Interpreter and/or translation fees: we usually gain quotes from several external interpreters and/or translators to ensure that our clients get the best deal
- Independent expert reports. These reports are not required in many cases but we will let you know as soon as possible if we consider that an expert report is necessary and obtain quotes on your behalf if you wish to proceed
- If there is an interview and we do attend with you, there will be additional disbursements in respect of our mileage/travel expenses in addition to our fees
- English language test/ECCTIS reports
- Tuberculosis test certificates
- Administrative fee for undertaking identity checks (£10 plus VAT per client)
- [Home Office fees](#) for submitting the application on your behalf, including priority service fees and Immigration Health Surcharge. You will pay these fees directly to the Home Office as part of the application process
- Where the Home Office refuses your application, advice and assistance in relation to any appeal, administrative review or reconsideration request, including the relevant fee

TIMESCALES

We cannot guarantee how long the Home Office will take to process your application. The current processing times for applications from outside the UK can be found [here](#) and inside the UK can be found [here](#).

We will normally be able to prepare and submit applications within 2 - 3 weeks of you instructing us depending on the complexity of your matter, but we will let you know at the earliest opportunity if it is likely to take longer than this. However, where your application is urgent, we may be able to prepare and submit your application within 2 – 3 working days. This is dependent on you meeting the requirements of the Immigration Rules applicable to your application and you being able to provide all the necessary information/documentation promptly,
